

Are most believers in God & his Son oblivious to the approximately two million innocent people put to death by God's order and documented in the Bible? In the name of religion, hundreds of millions of people have died all believing they are right. Only a strong, open mind can answer the other question presented in this novel, "What do I know and how do I know it?"

Following a new city ordinance banning any form of blasphemy, David Stone announces he is a non-believer at a public Sundown Service. David, philosopher/teacher is idealistically driven by his belief, that a world could be created where people use their intellect to overcome their ignorance; therefore no longer believing in superstition or unfounded beliefs.
